### TITLE I SCHOOL-LEVEL PARENT & FAMILY ENGAGEMENT POLICY

#### Section I: Involvement of Parents in the Title I Program

To involve parents in the Title I program at VAPA Legacy School the following practices have been established:

- The school provides parents of Title I students with a description and an explanation of the curriculum used at the school, the academic assessments used to measure student progress, and the achievement levels students are expected to meet with the state standards. Additionally, the school holds multiple workshops throughout the year to review curriculum and how to support at home.
- If requested by parents of Title I students, the school provides opportunities for regular meetings to formulate suggestions and to participate in decisions relating to the education of their children, and to respond to any such suggestions as soon as possible. Parents are invited to join the ELAC committee to review data and provide feedback on ways to improve student instruction. Parents are also welcome to attend Comprehensive Needs meetings to review student progress and identify areas of need and develop ways to support.
- If the School Plan for Student Achievement is not satisfactory to Title I parents, the reasons will be shared in this policy.

## Section II: Building Capacity for Involvement
